SPECIFIC INSTRUCTION ON HOW TO REACH DRMO FROM MAJOR INTERSTATE OR MAJOR POINT OF REFERENCE:

For all customer traffic: Utilize I-81 to exit 48 and proceed East on NY 342 to the second light and turn left onto RT 11. Continue on RT 11 to the second light and turn right onto RT 26 South. Follow RT 26 for 4 miles (the second flashing caution light) and turn Right onto Oneida Avenue. This will bring you to the Commercial Vehicle Gate. **(Note: All non authorized ID holders and Trucks must utilize this gate).** You will need picture identification, current vehicle registration and proof of insurance to gain admittance. After processing and you receive your pass, proceed West on Oneida Avenue for 1.4 miles. The DRMO is located to your left across the median. Please return pass at the gate you depart.
