**SPECIFIC INSTRUCTION ON HOW TO REACH DRMO FROM MAJOR INTERSTATE OR MAJOR POINT OF REFERENCE:**

From Baltimore Washington International (BWI) Airport, take 295 South (the sign will say "to Washington"), continue South on 295 for approx 10 miles. Take the Odenton/Ft. Meade Exit onto Route 175. Travel East on Route 175 approx 1 ½ miles to Reece Road. Turn right on Reece Road. The Visitor Center will be on the left. If you do not have a government vehicle and proper identification, you will stop here to get an escort. Otherwise, after you process through the guard; make a left on Ernie Pyle Street. Go to Mapes Road and make a right. Go past the military police station that will be on your left and make a left on Zimborski Avenue. Zimborski ends at Rock Avenue. DRMO Meade is on the corner of Rock Avenue and Zimborski Avenue. ( See Map on Page 3)
